

STREAMING LICENSE

TERMS OF SERVICE

Terms of service (hereafter “TOS”) for the licensing of individual films from the catalogue a minimum of three years or the life of the film.

Introduction & Definitions

This Agreement is by and between Blue Lion Films Inc., and the person(s) and/or organization acquiring the our film(s) for the benefit of the institution at which such person is employed (such organization is the “Institution” and such person is “You” or “Your”). Blue Lion Films Inc., and the Purchaser (on behalf of Yourself and the Institution) hereby agree as follows:

Blue Lion Films Inc. streams Content to Institutions (universities, schools, libraries, and other education institutions), which use such Content for viewing purposes only within their institution or fundraising purposes. Blue Lion’s online digital video Content for which licenses are available for purchase are provided via the online platform at <https://www.africanamericansinparis.com>, where you will be re-directed to purchase our videos on Vimeo. You may download a copy of this license agreement for your files and email to info@africanamericanparis.com, which we will file with a copy of your order for our records.

Acceptance of Terms

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms, then you may not access the Service.

Grant of Rights

Subject to the terms and conditions of this Agreement, for the applicable License Term, and subject to full payment of the Price, Blue Lion films grants to you a nonexclusive, nontransferable, limited license, without right of sublicense, to access and exhibit the Content on a streaming-only basis via your own URL or/and through Blue Lion Film’s Vimeo site. “Authorized Users” means the Institution’s currently enrolled students, employees, faculty, staff, affiliated researchers, distance learners, authorized attendees at educational classes hosted by the Institution, and visiting scholars authorized to view the Content including by remote access through an authentication (proxy) server that guarantees access only by Authorized Users. “Authorized Use” means real-time viewing of a digital transmission, for educational purposes only.

User Conduct

Blue Lion Films Inc. reserves all rights not granted herein. You shall not, and shall not permit any third party to: (a) copy, store, upload or download, or otherwise reproduce the Content; or(b) use the license to access Content for which a subscription has not been purchased.

Terms of Payment

The Institution must pay the price prior to downloading the film. Upon payment, the licensed work may be downloaded to add to your library or school server or to show for classroom, nonprofit event and fundraising events. Film is provided as a link or can be downloaded as an MP4 file only. Any other format will need to be requested and additional fee for conversion will be charged.

License Period

The license period commences at the time the film is given access and for the life of the film, until the film is retired and no longer available for viewing. .

Modifications to the Service

We reserve the right, at our sole discretion, to modify or replace these Terms at any time. If a revision is material, we will try to provide at least 14 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.

Term of Agreement

This Agreement will commence on the date the Order is placed (the "Effective Date") and will remain in effect until terminated by Blue Lion Films Inc. as specified under the License Period.
